The LEA used online surveys to collect input from various stakeholder groups, including students, faculty/staff, parents/families, and school- & district-level administrators. This included those administrators overseeing the special education program. These surveys provided information that supplemented input that we had already gathered from stakeholders through the LCAP development process. The survey was accessible via the school website and a message that was sent via email and text message. The survey and all related messages were translated into all languages spoken by students and their families, to ensure accessibility.

Additionally, faculty/staff input was solicited through discussion that took place during scheduled meetings. Engagement took place in various meetings, such as Parent Advisory groups, English Language Advisory committees and during staff meetings to ensure all education partners were involved.

Principals and other school leaders participated in a series of meetings with district administrators to solicit their input and to work collaboratively on the development of the plan.

Parents had the opportunity to participate in a town hall meeting, conducted in both English and Spanish, where they were invited to ask questions and provide input.

For all school input events, the LEA proactively reaches out to various community advocacy groups, including those that advocate for civil rights, for students with disabilities, for English Learners, and for other historically underserved populations.

Through the input process, we identified the areas of focus that formed the foundation of our ESSER III expenditure plan. These areas include: expanded opportunities for completion of unfinished learning and personalization of learning, including 1:1 tutoring and small group supports, 2) expanded extra-curricular and wellness programs to support social-emotional wellbeing, and 3) additional supplies for students who are struggling due to learning loss.

Community input was solicited through surveys and community meetings, as described above. Three major themes emerged from the feedback provided by the community: 1) we need to expand opportunities for completion of unfinished learning and personalization of learning, including 1:1 tutoring and small group supports 2) we need to expand extra-curricular and wellness programs to support social-emotional wellbeing and 3) we need to ensure that we have additional supplies for students who are struggling due to learning loss.

All of these areas are addressed in the plan.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

    - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
    - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Purchasing supplies to sanitize and clean the facilities of an LEA, including buildings operated by such agency;
  - Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;
  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
  - Addressing learning loss among students, including underserved students, by:
    - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
    - Implementing evidence-based activities to meet the comprehensive needs of students,
    - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
    - Tracking student attendance and improving student engagement in distance education;
- Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.
- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;

- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
