Additionally, faculty/staff input was solicited through discussions that took place during scheduled meetings.

Students participated in a lesson that was incorporated in their College & Career Readiness curriculum, in order to engage them in the process. This lesson introduced them to the survey and supported them with thinking about and providing their input.

Parents had the opportunity to participate in a town hall meeting, where they were invited to ask questions and provide input.

Three major themes emerged from the feedback provided by the community: 1) we need to expand opportunities for completion of unfinished learning and personalization of learning, including 1:1 tutoring and small group supports 2) we need to expand

extra-curricular and wellness programs to support social-emotional wellbeing and the development of Habits of Success, and 3) we need to ensure that our facilities support the above priorities by providing additional technology equipment and safe quality working environments within the classrooms.
