KEY POINTS


 Revenue is projected to be \$245K higher than budget, but that masks three significant shifts from last month:

- Interest/Dividend Income has been decreased by \$685K to better reflect trends.
 - Given increased costs due to staffing challenges, there is an increased reliance on one-time COVID funding of \$790K.
- Forecast food services revenues have been increased by \$390K to account for trending claims and higher reimbursement rates.
- There is legislative momentum around a "hold harmless provision" for charter schools that would allow them to use 2019-20 ADA. That would not impact ACES or TAS but could increase LCFF revenue at WAHS by ~\$475K.
- Expenses in this forecast have increased significantly from last month to account for an accelerating trend in contracted staffing (e.g., Substitutes, Special Education, Temps) with a few other line items that are also going to exceed budget (see notes for additional detail).



THE ACCELERATED SCHOOLS Financial Analysis January 2022

Net Income

The Accelerated Schools is projected to achieve a net loss of -\$1,883K in FY21-22 compared to -\$1,333K in the board approved budget. Reasons for this negative -\$550K variance are explained below in the Income Statement section of this analysis.

While the forecast net loss is negative, the forecast operating income is \$180K and the EBITDA is \$370K.

Balance Sheet

As of January 31, 2022, the school's cash balance was \$35.26M. By June 30, 2022, the school's cash balance is projected to be \$35.07M, which represents a 123% reserve.

As of January 31, 2022, the Accounts Receivable balance was -\$15K, up from -\$25K in the previous month, due to the receipt of revenue earned in FY20-21.

As of January 31, 2022, the Accounts Payable balance, including payroll liabilities, totaled \$998K, compared to \$733K in the prior month.

As of January 31, 2022, the organization had a debt balance of \$9.59M.

Income Statement

Revenue

Total revenue for FY21-22 is projected to be \$28.69M, which is \$246K or 0.6% over budgeted revenue of \$28.45M. Note both the budget and the forecast revenue have been adjusted from prior months to reflect the elimination of management fee revenue at the consolidated level.

- \$205K lower in LCFF due to declining ADA from Months 3-5.
- \$390K increase in Federal and State Nutrition revenue to account for trend as well as increased reimbursement rates.
- \$790K increase in All Other Federal Revenue (8299) reflecting the increased use of onetime Covid funds to cover increased substitute, staffing, and special education costs.
- \$685K lower Interest & Dividend Income (8660) to adjust to trend and align with board guidance.
- \$112K lower Net Increase (Decrease) in Fair Value of Investments to zero out that line in the budget. Please note that as of the end of January this line would result in a negative impact of \$817K on net income.
- \$23K higher in SELPA Grants due to receipt of LAUSD STEP Grants.

Expenses

This report will discuss revenue and expenditure variances from the Board-approved budget that are above \$20,000 and 10%.



Total expenses for FY21-22 are projected to be \$30.58M, which is \$796K or 2.67% over budgeted expenditures of \$29.78M. As was the case with revenue above, the budget and forecast revenue amounts have been adjusted to reflect the elimination of management fee expense at the consolidated level.

- \$473K lower than budget in Certificated Salaries due to the following:
 - o 3 unplanned vacancies totaling \$233K
 - o 3 open positions (non-classroom) totaling \$240K
 - \$137K lower than budget in Classified Salaries due to the following:
 - 12 unanticipated vacancies (part-time positions) filled by Outside Contracted Services
- \$227K lower in Health & Welfare.
- \$99K higher in Non Capitalized Equipment.
- \$130K higher in Nutrition Program Food & Supplies reflecting an update based on spending trends. This is offset with the increased revenue mentioned earlier.
- \$47K higher on Housekeeping Services.
- \$36K higher on vendor repairs.
- \$106K higher on legal expenses
- \$265K higher in Contracted Substitute Teachers (offset by savings in Certificated Salaries).
- \$733K higher in Contracted Special Education services.
- \$33K higher in non-public school placement costs.
- \$78K higher in After School Services to account for increased ASES funding levels.
- \$158K higher in All Other Consultants & Services for increased use staff support services due to COVID and staffing vacancies.

Note: Month 6 ADA is not yet finalized and so no updates to ADA have been made since last board meeting.

<u>ACES</u>

Budgeted average ADA for FY21-22 is 471.81 based on an enrollment of 508 and a 93.0% attendance rate.

The forecast assumes an ADA of 469.84 based on an enrollment of 508 and a 92.0% attendance rate.

In Month 5, ADA was 438.26 with 509 students enrolled at the end of the month and a 85.9% ADA rate.

Average ADA for the year (through Month 5) is 469.80 (a 92.4% ADA rate for the year to date).

TAS

Budgeted average ADA for FY21-22 is 714.03 based on an enrollment of 783 and a 92.0% attendance rate.

The forecast assumes an ADA of 709.00 based on an enrollment of 783 and a 92.0% attendance rate.

In Month 5, ADA was 667.68 with 769 students enrolled at the end of the month and a 86.8% ADA rate.

Average ADA for the year (through Month 5) is 705.73 (a 92.4% ADA rate for the year to date).

WAHS

Budgeted average ADA for FY21-22 is 443.12 based on an enrollment of 504 and a 88.7% attendance rate.

The forecast assumes an ADA of 434.39 based on an enrollment of 504 and a 88.0% attendance rate.

In Month 5, ADA was 392.11 with 493 students enrolled at the end of the month and a 79.5% ADA rate.

Average ADA for the year (through Month 5) is 428.88 (a 87.3% ADA rate for the year to date).
